SANCTION AUTHORIZATION

A CAGG SANCTION FORM IS REQUIRED FOR ALL TEAMS TRAVELLING OUTSIDE OF CANADA FOR INTERNATIONAL COMPETITIONS AND REPRESENTING CANADA

As of January 1, 2020, all AGG teams are required to complete a **CAGG Sanction Authorization form** and submit application fees (\$50.00 per club for up to 4 teams) to be allowed to represent Canada and compete internationally. AGG clubs are to abide by the instructions below:

AGG CLUB REQUIREMENTS:

1. Prior to submitting this authorization form, the AGG Club **MUST** be an A member in good standing with CAGG and all Club Membership fees paid to date.
2. All gymnasts on the AGG team must be members in good standing with their gymnast license fee paid for the competition year.
3. Coaches and/or judges must hold a clear valid Police Vulnerable Sector Screening certificate (valid during the period of travel)
4. List of additional members of Delegation travelling with team
5. The Club must provide the team and Delegation with its AGG Club “Code of Conduct” handbook for reference when travelling
6. All coaches **MUST** be of legal age (minimum 18 years) and possess a minimum NCCP Level 2 certification
7. Judges **MUST** be of legal age (minimum 18 years) and possess international judging status.
8. All costs associated with the AGG travel is paid for by the Club
9. One authorization form is to be completed per AGG team, by the Club owner with details of competition. A copy of the international event **MUST** be submitted along with sanction application form.
10. It is highly recommended that teams submit their sanction application and receive approval from CAGG prior to making any travel arrangements and booking flights.
